(a) & (b): The Airports Authority of India, the Implementing Agency has awarded 954 valid routes till completion of four rounds of bidding under Regional Connectivity Scheme(RCS)-Ude Desh Ka Aam Naagrik(UDAN) in the country to Selected Airline Operators(SAOs). The State/UT wise details are attached as Annexure.

An amount of Rs.1914 crore as Viability Gap Funding (VGF) have been disbursed to the SAOs from Regional Air Connectivity Fund Trust. More than one crore passengers have availed benefit of the flights operated under UDAN scheme since its inception.
