- (a) the details of the projects being operated by the National Project Construction Corporation Limited (NPCC) in the country during the last three years and the current year, State-wise;
- (b) the details of works being executed by the private agencies, State-wise;
- (c) the name of works in which NPCC has been blacklisted, State-wise; and
- (d) the total number of complaints received against officials of NPCC during the last three years and the present status of such complaints?

ANSWER

(a) & (b) National Project Construction Corporation Ltd (NPCC) has handled 399 projects during 2019-20, 422 projects during 2020-21, 314 projects during 2021-22 and 355 projects during the current year in the country. The State wise details are at **annexures “A”, “B”, “C” & “D”** respectively. NPCC engages private agencies to execute components of projects as per requirement.

(c) NPCC has been blacklisted by Jharkhand Police Housing Corporation Limited (JPHCL) for Jharkhand Police Housing Work at Pakur, in Jharkhand.

(d) Out of total 51 complaints received during last three years (2019-20 to 2021-22), 24 complaints have been closed and charge sheet has been issued in one case.
