### IMPLEMENTATION OF NHM IN RAJASTHAN

### 961. SHRIMATI JASKAUR MEENA:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the salient features of the National Health Mission;
- (b) the details of funds sanctioned, allocated and utilised in Rajasthan under the Mission during each of the last three years and the current year;
- (c) the details of targets set and achievements made so far under NHM in Rajasthan as a result thereof;
- (d) the details of the number of projects sanctioned in Rajasthan under the Mission along with their present status thereof; and
- (e) the details of the steps taken by the Government to complete these projects expeditiously?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a): National Health Mission (NHM) envisages achievement of universal access to equitable, affordable & quality health care services that are accountable and responsive to people's needs. NHM encompasses its two Sub-Missions, the National Rural Health Mission (NRHM) and the National Urban Health Mission (NUHM). The main programmatic components include Health System Strengthening in rural and urban areas, Reproductive-Maternal- Neonatal- Child and Adolescent Health (RMNCH+A) and Communicable and Non-Communicable Diseases.

Under National Health Mission (NHM), Ministry of Health & Family Welfare, Government of India provides financial and technical support to States/UTs including support for health/medical facilities, upto District Hospital level, based on the proposals submitted by States/UTs in their Program Implementation Plans (PIPs). Government of India provides approval for the proposals in the form of Record of Proceedings (RoPs) as per available resources.

  - v) Close monitoring and evaluation of services provided against carefully set standards
  - vi) Intersectional convergence of health and related programmes from village level upwards
