- (a) the details of funds disbursed to the State of Andhra Pradesh for implementing centrally sponsored schemes during the last five years;
- (b) whether the State has contributed matching components for the implementation of these schemes in the last five years;
- (c) if so, the details thereof along with the funds contributed by the State Government classified year-wise for the last five years;
- (d) whether the State Government has submitted the utilization certificates for the funds utilized under the schemes;
- (e) if so, the details thereof classified year-wise for the last five years; and
- (f) if not, the reasons therefor?

(a) to (f): The Ministry of Finance allocates funds through the budgetary process to different Ministries/Departments for each of the schemes/programmes including the Centrally Sponsored Schemes (CSS). Thereafter, the respective Ministry/Department releases Central share of CSS funds to State Governments as per guidelines of the respective schemes. Subsequent releases to States are based on submission of Utilization Certificates as per General Financial Rules (GFRs) for the funds released earlier. The funds that remain unutilized are adjusted towards the Grants-in-Aid payable during the next financial year. The year-wise details of funds released under the CSS to the State of Andhra Pradesh in the last five years from 2019-20 to 2023-24 are as follows:
