Development of STs has been one of the top priorities of the Government, which is reflected in increased budget allocation for welfare of Scheduled Tribes over the years. In Union Budget 2023-24, an amount of Rs. 1,17,943.73 crore has been allocated as DAPST funds out of the total scheme budgetary allocation of obligated Ministries/Departments which is about 5.5 times increase in DAPST funds allocation than that of the actuals of Rs 21525.36 crores in FY 2013-14. Further, budget of Ministry of Tribal Affairs has also increased about 2.7 times in 2023-24 in comparison to 2015-16.

The increasing trend in DAPST expenditure is likely to continue in accordance with the changes in need assessment for tribal development.
