Will the Minister of ROAD TRANSPORT AND HIGHWAYS

- (a) the details of capital expenditure incurred by National Highways Authority of India (NHAI) during each of the last five years, highlighting the 20 per cent increase to 2.07 trillion during the financial year 2023-24;**
- (b) the details of key projects and initiatives funded by the increased capital expenditure along with expected timelines and outcomes thereof, particularly in West Bengal;**
- (c) the details of distribution of capital expenditure by NHAI across India and infrastructure developments made thereunder, State and region-wise, particularly in Darjeeling Parliamentary Constituency in West Bengal; and**
- (d) the details of economic and employment impact due to NHAI's increased capital expenditure?**

STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (d) OF LOK SABHA STARRED QUESTION NO. 58 ANSWERED ON 25.07.2024 ASKED BY SHRI RAJU BISTA REGARDING CAPITAL EXPENDITURE OF NHAI

(a) The details of capital expenditure incurred by National Highways Authority of India (NHAI) in last five years is as under:-

(b) Major initiative was start of Bharatmala Pariyojana under which NHAI has awarded 23,282 km and 16,010 km has been constructed till Jun-2024. NHAI has taken up key 21 Greenfield Expressways/ Access Controlled corridors and constructed 4,293 Km. Out of these 21 corridors, one corridor of Varanasi-Ranchi-Kolkata is in West Bengal (Out of its total length of about 612 km, length in West Bengal is 260 km). Further A list of important projects taken up in the state of West Bengal is at Annexure-I.

(c) Details of State / Union Territory (UT) – wise expenditure incurred by NHAI towards development and maintenance of NHs, including for Darjeeling Parliamentary Constituency in the State of West Bengal, during each of the last five years is at Annexure-II.

(d) Capex has been incurred on development of NHs which is one of the prime mover of the economy contributing to the faster economic growth and development.

In last 5 years, NHAI has constructed 24,050 km of NHs with estimated 45 Crore man days of direct employment, 57 Crore man days of indirect employment and 532 Crore man days of induced employment.
