#### INTEGRATED CHILD PROTECTION SERVICES SCHEME

#### \*61. SHRI CHAMALA KIRAN KUMAR REDDY:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the details of funds allocated under the Integrated Child Protection Scheme (ICPS) during the last five years, year-wise, State-wise;
- (b) the number of children who were benefited under the ICPS Scheme during the said period especially in the State of Telangana, district-wise, year-wise;
- (c) whether the Government has conducted any assessment regarding the effectiveness of ICPS in providing a safe and protective environment for children, if so, the details thereof and if not, the reasons therefor; and
- (d) whether any initiatives have been undertaken to strengthen the implementation of ICPS and address the challenges faced in its execution, if so, the details thereof?

# STATEMENT REFERRED TO IN REPLY TO PART (A) TO (D) OF THE LOK SABHA STARRED QUESTION NO.61 FOR ANSWER ON 26.07.2024 RAISED BY SHRI CHAMALA KIRAN KUMAR REDDY REGARDING INTEGRATED CHILD PROTECTION SERVICES SCHEME

(a): The Ministry of Women and Child Development is administering the Juvenile Justice (Care and Protection of Children) Act, 2015 (JJ Act, 2015) (as amended in 2021) which is the primary legislation for ensuring the safety, security, dignity and well-being of children. Under this, the Ministry of Women and Child Development is implementing a Centrally Sponsored Scheme namely 'Mission Vatsalya' (erstwhile Integrated Child Protection Services (ICPS) Scheme) to support the State Governments and UT Administrations for delivering services for Children in Need of Care and Protection (CNCP) and Children in Conflict with Law (CCL).

During the last five years period, State-wise and year-wise details of funds released under the Mission Vatsalya Scheme, are at **Annexure-I**.

- (b) : The State-wise number of children benefited under the Mission Vatsalya Scheme during the last five years period including the State of Telangana is at **Annexure-II**. The district-wise information regarding children benefitted under Mission Vatsalya Scheme is not maintained centrally.
- (c) National Institution for Transforming India (NITI) Aayog in 2020 conducted an evaluation study for all Schemes of the Women and Child Development (WCD) including erstwhile Integrated Child Protection Services (ICPS) Scheme. The Study captured the broader canvas of effectiveness, efficiency, impact etc. across the schemes of the Ministry. The Study was conducted across 12 States/UTs.

The findings of the Study *inter-alia* mention that the (erstwhile) ICPS scheme was in accordance with the provisions envisaged under the JJ Act, 2015 and contributed for improvement in the statutory service delivery structures under the Scheme. It mentioned about the cost norms and focus areas of the Scheme and emphasized upon requirements of training and capacity building of all the functionaries.

(d) The Ministry constantly engages with the States/ UTs from time to time as regards implementation of Mission Vatsalya Scheme. The Ministry has issued various advisories and held Zonal Conferences and Sensitization/ Dissemination Workshops under the Scheme for supporting on ground implementation.

The initiatives taken under the Mission Vatsalya Scheme include collaboration with National Institute of Mental Health and Neurosciences (NIMHANS), Bangalore under "SAMVAD" (Support Advocacy & Mental Health Interventions for Children in Vulnerable Circumstances and Distress). SAMVAD works in areas of Mental Health, Care & Protection, Education and Policy & Law. Various training and capacity building programmes have been conducted for child protection functionaries and others stakeholders across the States/ UTs.

Also the Ministry in collaboration with Lal Bahadur Shastri National Academy of Administration (LBSNAA), Mussoorie has developed an online training module on Juvenile Justice (Care and Protection for Children) Act, 2015 (as amended in 2021) for capacity building of multiple stakeholders such as State Governments/ UT Administrations, district authorities and others.
