Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the details of beneficiaries that have been covered under the PM-Ayushman Bharat Health Infrastructure Mission (PM-ABHIM) in Bhubaneswar Lok Sabha constituency, Odisha since its launch, year and area-wise;
- (b) the total funds allocated and utilized under such yojana particularly in Bhubaneshwar constituency, Odisha since its launch, year and area-wise;
- (c) the total number of private hospitals which are currently empaneled in such constituency, Odisha;
- (d) the steps taken by the Government to raise public awareness about such yojana; and
- (e) whether eligible beneficiaries are informed and able to access the benefits of such yojana and if so, the details thereof, area-wise?

STATEMENT REFERRED TO IN REPLY TO LOK SABHA STARRED QUESTION NO. 78 FOR 26TH JULY, 2024

- (a) to (e) The **PM-Ayushman Bharat Health Infrastructure Mission** (**PM-ABHIM**) was launched on 25th October, 2021 with an outlay of **Rs.64,180** Cr to be implemented over five years from 2021-22 to 2025-26, with the aim to strengthen the public health infrastructure to fill critical gaps in health infrastructure, surveillance and health research spanning both the urban and rural areas.
 - Under Centrally Sponsored Components of the scheme, support is provisioned to the States/UTs for:
 - Construction of 17,788 Rural building-less Sub Health Centers-Health and Wellness Centers, now renamed as Ayushman Arogya Mandir (AAM).
 - Establishment of 11,024 Urban Ayushman Arogya Mandir in all the States with a focus on slum and slum like areas
 - Establishment of 3382 Block Public Health Units at block levels.
 - Setting up of 730 Integrated Public Health Labs in all districts across the Country.
 - Establishment of 602 Critical Care Blocks (50/75/100 bedded) in all the districts with population more than 5 lakhs and referral linkages in other districts.

Administrative approvals has been accorded to State of Odisha for FY 2021-22, 2022-23 & 2023-24, for an amount of Rs 763.52 Crore for construction/strengthening of 604 Sub-Health Centres - Ayushman Arogya Mandir (AAM), 75 BPHUs, 15 IPHLs at District level and 15 CCBs as per proposal of the State. An amount of Rs. 418.50 Crore is released to the State of Odisha under the scheme from FY 2021-22 to FY 2023-24. Details of year wise approvals and releases are attached in Annexure-I.

PM-ABHIM is an infrastructural development scheme for strengthening the infrastructure of public health facility and there is no provision for empanelment of private hospitals under the scheme.

In the Bhubaneshwar Lok Sabha Constituency, support under the scheme is provided for establishment of 1 CCB (50 bedded) and 1 Integrated Public Health Laboratory (IPHL) at District Hospital Khurda, 8 Block Public Health Units (BPHUs) and construction of 17 Building-less Sub-Health Centres – Ayushman Arogya Mandir (AAM). The construction work is undergoing at all the projects site.

The scheme is being implemented by the State government and awareness generation activities including IEC for the scheme is periodically conducted by the State health department along with other public health programs under National Health Mission.
