#### TRAINING COURSES FOR YOUTH UNDER PMKVY SCHEME

#### \*9. SHRI MAGUNTA SREENIVASULU REDDY: SHRI PUTTA MAHESH KUMAR:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

(a) whether the Government has carried out any research/study/survey to provide training courses to youth across the country for purposes of upskilling and/or reskilling under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY) Scheme;

(b) if so, the total number of individuals who have signed up for such courses during the last five years, State-wise, particularly Andhra Pradesh;

(c) the details of the total amount of funds allocated and utilised for centres carrying out such training during the last five years in Andhra Pradesh, district-wise, particularly in Eluru District; and

(d) whether the Government has carried out any awareness campaign/promotional activities for the purposes of informing citizens of the upskilling/reskilling course available under PMKVY Scheme, if so the details thereof?

## STATEMENT REFERRED TO IN REPLY TO PARTS (A) AND (D) OF LOK SABHA STARRED QUESTION NO. \*9 TO BE ANSWERED ON 22.07.2024 ASKED BY SHRI MAGUNTA SREENIVASULU REDDY AND SHRI PUTTA MAHESH KUMAR REGARDING TRAINING COURSES FOR YOUTH UNDER PMKVY SCHEME

(a) Yes, Sir. A robust stakeholder consultation and regulatory framework has been established for conducting necessary research/study/survey to provide training courses under Pradhan Mantri Kaushal Vikas Yojna (PMKVY) to youth for purposes of upskilling and/or reskilling.

Sector Skill Councils (SSCs), mandated under the National Policy on Skill Development and Entrepreneurship (2015), actively engage with industries to identify skill gaps through regular consultations and studies. The National Skill Development Corporation (NSDC) commissions studies focusing on both Indian and global labour markets to ensure comprehensive skill assessments.

Based on these consultations and studies, competency standards and qualifications are developed for high-demand job roles. These qualifications undergo validation through consultations with industries accredited by the National Council for Vocational Education and Training (NCVET). Validated qualifications are then added to the National Qualification Register (NQR) and aligned to the National Skills Qualification Framework (NSQF).

All training courses offered under PMKVY are drawn from this National Qualification Register (NQR) and are developed based on industry consultation and skill gap surveys as detailed above.

In addition to the above, District Skill Development Plans (DSDPs) have been developed by District Skill Committees (DSCs) to assess skill gaps, mapping of industry demand, etc. at district level to ensure alignment of PMKVY courses with local needs.

Further, an Impact Evaluation of the Pradhan Mantri Kaushal Vikas Yojana was also conducted in the year 2019 to evaluate the impact of the scheme.

(b) Under PMKVY, as on 31.03.2024, a total of 1,13,884 candidates have been enrolled in the last five years for upskilling and/or reskilling in Andhra Pradesh.

State-wise numbers of candidates who have been enrolled during the last five years for upskilling and/or reskilling under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY) Scheme are given at **Annexure I.** 

(c) Under PMKVY, there is no provision to allocate fund directly to Districts. Details of district-wise utilization of funds for carrying out upskilling and/or reskilling training during the last five years in Andhra Pradesh, are given at **Annexure II.** 

(d) Yes, the MSDE has undertaken various awareness campaigns and promotional activities to inform citizens about the upskilling and reskilling courses available under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY) scheme through comprehensive multimedia campaigns across television, radio, print, and digital platforms; periodic media briefings with vernacular, regional and national media; active engagement on social media platforms; and community engagement initiative. Regular Press releases have also been issued through Press Information Bureau (PIB), Doordarshan, MyGov and other government and private news agencies.Awareness has also been created through our wide network of training institutes to disseminate information and encourage participation in the scheme.Utilizing the MSDE's digital initiative – 'Skill India Digital Hub' (SIDH), citizens can access detailed information about PMKVY courses, enroll in training programs, and locate the nearest centers where the scheme is running.
