Will the Minister of **COMMERCE AND INDUSTRY** be pleased to state: वाणिज्य एवं उद्योग मंत्री

- (a) the details and total number of beneficiaries under the Startup India Seed Fund Scheme during the last five years and the current year, State and district-wise especially in Andhra Pradesh;
- (b) the details and total number of industries established under this scheme, especially those started by individuals between the ages of 18-35 during such period, State and district-wise especially from Andhra Pradesh;
- (c) the details and total number of incubators who are attached with this scheme during the said period, State and district-wise especially in Andhra Pradesh;
- (d) the details and total amount of funds allocated and utilized for the purposes the Startup India scheme during the above period, State and district-wise especially in Andhra Pradesh;
- (e) whether the Government has considered introducing any incentives to individuals between the ages of 18-35 to avail the benefits under this scheme, if so, the details thereof;
- (f) the details of progress and current financial viability of these Startups; and
- (g) the number of Startups funded at the seed stage during the year 2022-23 alone?

ANSWER

वाणिज्य एवं उद्योग मंत्रालय में राज्य मंत्री (श्री जितिन प्रसाद(THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE & INDUSTRY (SHRI JITIN PRASADA)

(a) to (e): The Startup India Seed Fund Scheme (SISFS) has been approved for the period of 4 years starting from 2021-22 with a corpus of Rs. 945 crore. The Expert Advisory Committee (EAC) of SISFS, evaluates and selects incubators for allocation of funds. The approved incubators select startups in accordance with the guidelines. SISFS is implemented from 1st April 2021.

As on 30th June 2024, 205 incubators have been approved so far under SISFS for support of Rs. 862.84 crore of which Rs. 402.83 crore has been disbursed to the selected incubators. The approved incubators under SISFS have selected 2,332 DPIIT recognised startups from across the country for funding.

Specifically for the State of Andhra Pradesh, 7 incubators have been approved for a total sum of Rs. 29.40 crore. The incubators approved under the Scheme have selected 45 recognised startups from the State of Andhra Pradesh as on 30th June 2024.

The State/Union Territory (UT)-wise details of incubators approved under SISFS, since the operationalisation of the Scheme (i.e., with effect from 1st April 2021) to 30th June 2024 are placed as **Annexure-I**.

The district-wise details of incubators and startups in the State of Andhra Pradesh under SISFS, since the operationalisation of the Scheme (i.e., with effect from 1st April 2021) to 30th June 2024 are placed as **Annexure-II**.

The State/UT-wise details of number of startups selected under the Scheme by the incubators are placed as **Annexure-III**.

The benefits under SISFS are inclusive and can be availed across all agegroups.

- (f): Under SISFS, specifically for the State of Andhra Pradesh, the approved incubators have reported that several selected startups have completed milestones such as prototype development, product development, and raised external funding as a result of the support provided under SISFS.
- (g): Under SISFS, the approved incubators have selected 2,332 recognised startups from across the country for funding as on 30th June 2024 with 569 recognised startups selected in 2022 and 1,025 recognised startups selected in 2023.
