FUNDS ALLOCATED UNDER MGNREGS

Will the Minister of RURAL DEVELOPMENTbe pleased to state:

- (a) whether it is a fact that the Union Government is yet to allocate the Centre's share of allocations for Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) wages for many States including West Bengal and Kerala;
- (b) if so, the details of the MGNREGS dues to the States during each of the last three financialyears and current year, year and State-wise particularly for West Bengal and Kerala;
- (c) whether the Government has decided/fixed any time schedule to disburse the dues, if so,the details of funds allocated under the MGNREGS during the said period, year and State-wise;
- (d) the details of funds allocated, released and utilized by the State Governments under the MGNREGS during the said period, year and State-wise particularly West Bengal;
- (e) the details of last payment along with the date of its release to the Government of WestBengal;
- (f) whether there has been misuse of fund and a good amount of money has been siphonedoff from across the country, if so, the details thereof; and
- (g) whether the Government has any proposal to hike the wage of MGNREGS workers, if so,the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI KAMLESH PASWAN)

(a)to(c): Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand-driven wage employment scheme. There are no dues pending for wage component payment, under Scheme for the Financial Year(s) 2021-22, 2022-23 and 2023-24 for any State/UT including Kerala, except the State of West Bengal.

In case of State of West Bengal, there is a pending liability of Rs. 4,137 crore for financial year 2021-22 and Rs. 1,416 crore for financial year 2022-23 as release of fund to the State underMahatma Gandhi NREGS have been stopped since 09th March 2022 as per provisions under section 27 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 due to non-compliance with directions of the Central Government.

As per the provision of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 the State Government is responsible for effective implementation and to ensure transparency and accountability in the implementation of the Scheme. Also, according to the provision of the Act, if the State Government is not fully successful in discharging its responsibility then the Central Government has the right to issue appropriate guidelines as well as to stop the release of funds.

This Ministry has communicated to the Government of West Bengal for compliance with the directions for which the compliance report is awaited.

State/UT-wise details of pending liabilities for the wage component under Mahatma Gandhi NREGS for the three Financial Year(s) 2021-22, 2022-23, 2023-24 and upto current FY 2024-25 (as on 25.07.2024) are given at Annexure-I.

State/UT-wise details of pending liabilities for material components under Mahatma Gandhi NREGS for the three Financial Year(s) 2021-22, 2022-23, 2023-24 and upto current FY 2024-25 (as on 25.07.2024) are given at Annexure II.

Under Mahatma Gandhi NREGS, States/UTs submit funds release proposals to the Government of India. The Ministry releases funds periodically in two tranches with each tranche consisting of one or more installments, keeping in view the "agreed to" LabourBudget, demand for works, opening balance, pace of utilization of funds, pending liabilities, overall performance and subject to submission of relevant documents by the States/UTs.

Fund release to the States/UTs is a continuous process and the Central Government is committed to making funds available to States/UTs for the implementation of the Scheme as per the demand for work on the ground.

State/UT-wise details of funds released under Mahatma Gandhi NREGS during the financial years from 2021-22 to 2024-25 (as on 25.07.2024) are given at Annexure-III.

- (d): State/UT-wise details of expenditure incurred (including State share) under Mahatma Gandhi NREGS from 2021-22 to 2024-25 (as on 25.07.2024) are given at Annexure-IV.
- (e): During the financial year 2021-22 (as on 31.01.2022), an amount of Rs.7,507,80 crore was released towards wage, material & administrative contingency to the State of West Bengal under Mahatma Gandhi NREGS.
- (f): Mahatma Gandhi NREGS offers employment opportunities to the rural population willing to do unskilled work while creating productive assets.

Several steps have been taken to strengthen transparency and accountability which include geo-tagging, Direct Benefit Transfer (DBT), National electronic Fund Management System (NeFMS), Aadhaar Based Payment System (ABPS) and National Mobile Monitoring System, Software for Estimate Calculation using Rural rates for Employment (SECURE), National Level Monitors (NLMs) and Social Audit.

To monitor the progress of the implementation of the Mahatma Gandhi National Rural Employment Guarantee Act, (Mahatma Gandhi NREGA) in States/UTs, independent agencies empanelled as National Level Monitors (NLMs) with the Ministry of Rural Development were deputed to conduct special monitoring visit. NLM Agencies were required to visit the selected districts to observe and monitor the progress made under the scheme and assess the quality of implementation therein.

Details of Monitoring Visits done by the Central team to different States and the amount recovered/recommended for recovery are as under:-

In addition to above, Section 17 of the Mahatma Gandhi NREGA, 2005 mandates the Gram Sabha to conduct Social Audits. The Act mandates Social Audit of works by Gram Sabha. States/UTs-wise detailed report on Social Audit recovery is annexed as Annexure-V.

Also, Para 30 of Schedule I of the Mahatma Gandhi NREGA mandates that there shall be an Ombudsperson for each District for receiving grievances, enquiring into and passing awards as per Guidelines. As of 25.07.2024, ombudspersons have received 8,784 complaints and more than 6,630 have been disposed of so far.

(g): As per Section 6 (1) of the Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA), 2005, the Central Government specifies wage rates for its beneficiaries. These rates are determined using the Consumer Price Index for Agricultural Labour (CPI-AL). In order to compensate the MGNREGA beneficiaries against inflation, Ministry of Rural Development revises wage rates annually, based on changes in the CPI-AL, with each State/UT having the option to provide wages higher than the rates notified by the Central Government.
