(a): As on July 24, 2024 the office of Geographical Indications Registry has registered 643 GI Applications, of which 605 GI Applications are Indian. Further, 21 GI Applications are registered from State of Rajasthan. The details of Geographical Indications (GI) tagged products in the country State/UT- wise is available on DPIIT's website under the links –

(b) to (e): The Office of Geographical Indications Registry, under the Office of Controller General of Patents, Designs & Trade Marks (CGPDTM), Ministry of Commerce and Industry is the nodal office & Quasi Judicial Authority, established to administer the Geographical Indications of Goods (Registration & Protection) Act, 1999 & Geographical Indications of Goods (Registration & Protection) Rules, 2002. The Office is performing its role within the legal framework of GI Act & Rules. The Government has earmarked Rs. 75 crores under the IPR Policy Management Scheme for period of three years i.e., FY 2022-23 to 2024-25 to undertake initiatives and activities aimed at creating awareness about significance of GIs, promoting registered Indian GIs, identify potential GIs and encourage stakeholders towards registration. Also, the GI Registry regularly conducts awareness programmes for stakeholders on GI at various places in the country and also provides necessary handholding facility to the applicants in the filing and processing of their GI applications.
