(a) whether many colliery projects in Chhattisgarh are pending for approval to start their mining activities;

(b) if so, the details thereof;

(c) the details of the quantum of coal produced across the various collieries in Chhattisgarh during each of the last five years, district-wise; and

(d) the quantum of the metallurgical coal produced in collieries of Chhattisgarh to be used for production of different kinds of steel during the last three years?

ANSWER

(a) & (b): Presently there are 06 projects pending approval in the State of Chhattisgarh. The details of issues pending in the State of Chhattisgarh, due to which some coal projects have not been started is given at Annexure-I:

(c): The details of the quantity of coal produced in Chhattisgarh during each of the last five years from 2019-20 to 2023-24 are given in Annexure-II.

(d): The quantum of the metallurgical coal produced in collieries of Chhattisgarh during the last three years are as under:

The tree-cutting permission was granted for 49.20 ha forest area on 19.04.2022 for Surajpur district and 70.94 ha forest area on 23.06.2022 for Sarguja district. However, due to resistance/agitation of local villagers and NGOs, tree cutting could not be commenced and coal production could not be started.
	Pending Tree Cutting Activities and handover of Forest land	Basan		18	 MoEF&CC granted FC stage- II for 1136.32 ha forest area (Phase II) on 02.02.2022. Subsequently, the Government of Chhattisgarh transferred forest land vide letter dated 25.03.2022 to RRVUNL. Out of the 134.84 hectares of land requested for 2022-23, only 43.63 hectares were initially handed over to the M/s RRVUNL and mining operations on this land were completed on September 23, 2023. Subsequently, an additional 26.82 hectares were transferred to RRVUNL for mining operations on December 29, 2023, and the handover of approximately 3.9 hectares of forest land to RRVUNL is still pending after completion of tree felling activity.

The detail of issues pending in State of Chhattisgarh:

					 Furthermore, tree felling activity by the State Forest Department of Chhattisgarh is still pending for 30 hectares. To continue mining operations at the PEKB Coal Block in the fiscal year 2024-25, an additional 74 hectares of land is urgently required for mining activities. The committed coal production for 2024-25 is 18 MT.
