- (d) the details of the incomplete works under the said project and the additional funds required to complete the project?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF UNSTARRED QUESTION NO. 1465 BY DR. MANNA LAL RAWAT TO BE ANSWERED IN LOK SABHA ON 31.07.2024 REGARDING PROJECT OF ELECTRIFICATION WORK OF THE RAILWAY LINE

(a) to (d) The electrification of 227 Route km (RKM) out of 297 RKM between Udaipur-Ahmedabad has been completed. The work between Bechhiwara to Himmatnagar (70 RKM) are taken up.

During the last 5 years, i.e. 2019-2024 Railway electrifications of record 2,799 RKM and 4,070 RKM have been commissioned in the state of Gujarat and Rajasthan respectively.

Commissioning of Railway Electrification in State of Gujarat during 2009-14 and 2014-2024 is as under:

Commissioning of Railway Electrification in State of Rajasthan during 2009-14 and 2014-2024 is as under:

| 2014-24 | 4,993 km | 499.3 km/year | 36.71 times |

The completion of Electrification project(s) depends on various factors like forest clearances, right of way for the incoming transmission lines and its commissioning, shifting of infringing utilities, statutory

clearances from various authorities, geological and topographical conditions of area, law & order situation in the area of project(s) site, number of working months in a year for particular project site due to climatic conditions etc. All these factors affect the completion time of the project(s).

Expenditure of ₹201.32 crore has been incurred for this project.
