MEGA FOOD PARK IN GUJRAT

† 1620. **SHRI JASWANTSINH SUMANBHAI BHABHOR:**

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) the present status of mega food parks in Gujarat;
- (b) the number of parks functioning in Gujarat at present;
- (c) the details of the invested funds received and estimated to be received for the said parks; and
- (d) whether the Government is likely to consider the proposal of setting up of a mega food park in Dahod in Gujarat in future and if so, the details thereof?

ANSWER

(a) & (b) Under the Mega Food Park Scheme (MFPS) which is a component scheme under the Pradhan Mantri Kisan Sampada Yojana (PMKSY), the Ministry has sanctioned 2 (two) Mega Food Park projects in the State of Gujarat. Out of these two projects, one project is operational and one project is under implementation. Details of MFP Projects in the state of Gujarat, along with their status of implementation are at **Annexure**.

(c) Currently one MFP project is operational in Gujarat. Total investment made in this project is approximately Rs. 122.00 crore, investment received from operational units as well as units under execution at the Park is approximately Rs. 377 crores.

(d) There is no such proposal as the scheme has been discontinued by the Government with effect from 01.04.2021 with provision for committed liabilities for ongoing projects only.
