UPGRADATION OF COLD CHAIN AND PRESERVATION INFRASTRUCTURE FACILITIES

1630. SHRI G M HARISH BALAYOGI:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) whether the Government has any scheme / project for the purpose of developing/ upgrading cold chain and preservation infrastructure facilities in the country;
- (b) if so, the details of the total number of cold chain and preservation infrastructure facilities established during the last five years across the country, State-wise including Andhra Pradesh;
- (c) the details of the total number of cold chain and preservation infrastructure facilities catering to fish and other such marine products established across Andhra Pradesh under such schemes during the last five years, district-wise particularly Bapatla District;
- (d) the details of the funds allocated for the schemes and utilised for the setting up / establishment of cold chain and preservation infrastructure facilities in Andhra Pradesh during the last five years; and
- (e) whether the Government has considered upgradation of such facilities under its schemes / projects in Andhra Pradesh and if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

(a), (b), (d) & (e) The Scheme for Integrated Cold Chain & Value Addition Infrastructure, a sub scheme of Pradhan Mantri Kisan Sampada Yojana (PMKSY) in the Ministry of Food Processing Industries (MoFPI) aims at creation of modern infrastructure with efficient supply chain management from farm gate to retail outlets. This will not only provide a big boost to the growth of food processing industries in the country but also improve the capacity of food processing units which help in providing better returns to farmers and creating employment opportunities especially in the rural areas, reducing wastage of agricultural produce, increasing the processing level and enhancing the export of the processed foods.

The State-wise and year-wise details of total number of cold chain and preservation infrastructure facilities established during the last five years in the country including the state of Andhra Pradesh as well as details of fund allocation and its' utilization are at **Annexure-I**.

(c) There is no project approved in Bapatla District in the state of Andhra Pradesh for catering to fish and other such marine projects. However, district-wise details of projects approved in the State of Andhra Pradesh during the last five years for catering to fish and other such marine products is at **Annexure-II**.
