Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of the expenditure incurred by the Government for establishing smart cities in the country including Tamil Nadu during the last three years, year-wise;**
- (b) whether the funds provided/being provided is sufficient to convert the existing cities into smart cities, if so, the details and if not, the steps taken/being taken in this regard;**
- (c) the names of the cities identified under Smart Cities Mission (SCM) in Tamil Nadu;**
- (d) the details of the districts in Tamil Nadu for which essential funds have been allocated under the said mission to develop them as smart cities;**
- (e) the details of the funds allocated and utilized so far for the said purpose;**
- (f) whether the work of smart city project in the said identified cities is likely to be completed on time, if so, the details thereof and if not, the reasons therefor; and**
- (g) the steps taken/being taken by the Government to expedite the works along with the progress report of the above said works?**

ANSWER

- (a) The details of the expenditure incurred by the Government or establishing smart cities in the country including Tamil Nadu during last three years, year wise is at Annexure-I.
- (b) Smart Cities Mission (SCM) launched on 25 June, 2015, has selected 100 cities through 4 rounds of competition from January 2016 to June 2018. The mission follows an Area-based smart city development, concentrating the efforts in selected part (ABD area) of the city. In the Smart City proposal, every city has encapsulated its projects in ABD area and some projects in Pan-city feature with Smart Solution(s). The focus of the mission has been on sustainable and inclusive development and creating replicable models. This Area-based development strategy has helped in completion of projects in shorter time frame, leading to its replication in other parts of the city. As per the data provided by 100 Cities, as of 12th July, 2024, 7,218 projects amounting to Rs. 1,45,083 crore (90% of total projects) have been completed.
- (c) to (e): 11 cities from Tamil Nadu have been selected under the Smart Cities Mission i.e., Chennai, Coimbatore, Madurai, Salem, Thanjavur, Vellore, Thoothukudi, Tiruchirapalli, Tirunelveli, Tiruppur and Erode.

Under the mission, each city can get a maximum of Rs. 500 crore of funds from the Central Government. All 11 cities in Tamil Nadu have received the full fund support from the Central Government under the mission. The details of funds allocated and utilized in the cities of Tamil Nadu is attached as Annexure-II.

- (f) The 11 cities of Tamil Nadu, selected under the Smart cities Mission have undertaken a total of 733 projects amounting to Rs. 17,984 crore. Of these total projects, the cities have completed 706 projects amounting to Rs. 17,390 crore. The mission period for completing the implementation of ongoing SCM projects has been extended upto 31 March, 2025.

(g) The Ministry has a multi-level review structure to expedite the progress of projects under the Mission. At State level, Mission implementation is monitored by the State Level High Powered Steering Committee (HPSC). At the National level, implementation is monitored by an Apex Committee headed by Secretary, Ministry of Housing and Urban Affairs (MoHUA). Nominee Directors of MoHUA on the Boards of SPVs monitor progress in respective cities on a regular basis. MoHUA also regularly interacts with the States/Smart Cities through video conferences, review meetings, field visits, regional workshops etc.
