#### **CNG PUMPS**

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether the Government has taken steps to promote the use of CNG in the country and if so, the details thereof;
- (b) whether there has been an increase in the number of CNG-operated vehicles and if so, the details thereof;
- (c) the details of the number of CNG pumps opened across the country during the last five years, State-wise including Gujarat; and
- (d) the details of the number of CNG pumps in Jamnagar and DevbhumiDwarka districts of Gujarat?

#### **ANSWER**

### MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SURESH GOPI)

- (a) Establishment of Compressed Natural Gas (CNG) stations is part of the development of City Gas Distribution (CGD) Network and the same is being carried out by the entities authorised by Petroleum and Natural Gas Regulatory Board (PNGRB) as per their Minimum Work Programme (MWP). After completion of 12/12A CGD bidding round, PNGRB has authorized entities for the development of CGD network in 307 Geographical Areas (GAs), covering almost 100% of the total geographical area of the country spread over around 733 districts in 34 states/UTs with MWP target of establishing 18,336 CNG stations across the country by 2032. To promote the use of CNG in the country the Government has taken various measures which includes diverting domestic gas from power and other non-priority sectors to meet the requirement of CNG(Transport) and PNG (Domestic) segments; declaring CNG(T)/PNG(D) sector as the first priority for allocation of domestic natural gas; priority to CNG(T)/PNG(D) sector for supply of High Pressure High temperature (HP-HT) gas in any situation requiring proportionate distribution of gas under the bidding process, etc.
- (b) There has been an increase in the number of CNG- Operated vehicles. As per Vahan dashboard maintained by Ministry of Road Transport & Highways, the total number of vehicles using CNG in 2020 were2,75,097and as on 26.07.2024 the number has increased to 72,22,371across the country.

- (c) The detail of State/UT wise cumulative number of CNG stations opened across the country including Gujarat during the last five years is at **Annexure**.
- (d). As on 31.05.2024, the entities have established 25 CNG stations in Jamnagar district and 05 CNG stations in Devbhumi Dwarka district of Gujarat.
