**NATIONAL URBAN LIVELIHOOD MISSION (NULM) AND SWARNA JAYANTI
SHAHARI ROZGAR YOJANA (SJSRY)**

NO. 1703. SHRI SANJAY HARIBHAU JADHAV:

Will the Minister of Housing & Urban Affairs be pleased to state:

- (a) whether it is proposed to mobilize the poor people living in the urban areas and provide them with opportunities for skill development under the National Urban Livelihood Mission (NULM) and the Swarna Jayanti Shahari Rozgar Yojana (SJSRY) and if so, the details thereof;**
- (b) the number of districts in the State of Maharashtra where the citizens have availed the benefits of the said scheme from the year 2013 to 2024;**
- (c) whether Parbhani Lok Sabha Constituency is included under the said scheme and if so, the details thereof;**
- (d) the extent of change in the lives after availing benefits of the said scheme by the beneficiaries along with the details thereof; and**
- (e) the extent to which the said two schemes are beneficial in promoting employment in the aspirational districts and to enhance the living standard of citizens along with the details thereof from the year 2013 to 2024?**

- (a) Urban development, including urban poverty alleviation is a state subject and the implementation of schemes/programmes under this is the responsibility of State/UT Governments. Ministry of Housing & Urban Affairs (MoHUA) supplements the effort of State/UT by providing Central Assistance under “Deendayal Antyodaya Yojana- National Urban Livelihoods Mission (DAY-NULM)”.**

The Swarna Jayanti Shahari Rozgar Yojana (SJSRY), implemented till 2013, had aimed at providing gainful employment to the urban unemployed and under-employed through setting up of self-employment ventures or provision of wage employment. On 23rd September 2013, SJSRY was restructured and launched as National Urban Livelihoods Mission (NULM). In February, 2016 the Mission was renamed as Deendayal Antyodaya Yojana - National Urban Livelihoods Mission and extended to all the statutory towns in the country.

The “Deendayal Antyodaya Yojana - National Urban Livelihoods Mission (DAY-NULM)” has the objective of reducing poverty and vulnerability of urban poor households by enabling them to access gainful self-employment and skilled wage employment opportunities, in order to improve their livelihoods on a sustainable basis, through building strong grassroots level institutions of the urban poor.

(b) & (c) DAY-NULM is implemented in all 35 districts of Maharashtra, including Parbhani Lok Sabha Constituency, with a total number of 8160 beneficiaries covered under the scheme.

(d) & (e) The Scheme is implemented for promoting employment in aspirational districts. As on 15.7.2024, the progress of DAY-NULM, across the country, is as under:
