- (c) whether the Government proposes construction of new flyovers or underpasses along the stretch of NH-6 from Dhulagarh to Kolaghat and if so, the details thereof;
- (d) the details of the beautification and road safety works undertaken on NH-6, including the portion in the Howrah district, during the last three years; and
- (e) whether the Government is considering to close down the toll at Dhulagarh on NH-6 and if so, the details thereof?
