Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) the details of the Centrally Sponsored Schemes and Central Sector Schemes being implemented by the Union Government for labour in the State of Maharashtra during the last three years and the current year;
- (b) the details of the funds allocated, sanctioned, released and utilized for each of the above scheme during the last three years and the current year, year-wise, scheme-wise and district-wise;
- (c)the number of labourers who got benefited from the above schemes in the State of Maharashtra during the said period;
- (d)whether the Government found any shortcomings while implementing above schemes and if so, the manner in which the Government fixed those shortcomings;
- (e)the challenges faced by the Union Government while implementing these schemes for the labourers; and
- (f)whether the Government intends to provide assistance to the State Governments to improve the condition of labourers in the country and if so, the details thereof?

ANSWER

MINISTER OF STATE FOR LABOUR AND EMPLOYMENT (SUSHRI SHOBHA KARANDLAJE)

(a) to (f): The schemes of Ministry of Labour and Employment are Central Sector schemes. Major schemes being implemented are:(i) Labour Welfare Scheme (LWS) for welfare of Beedi/Cine / Non-Coal Mine Contd..2/-

workers and their family members covering three components viz. health, scholarship and housing; (ii) Aatmanirbhar Bharat Rojgar Yojana (ABRY) to incentivise employers for creation of new employment and restoration of loss of employment during Covid-19 pandemic; (iii) National Career Service (NCS) for establishment of Model Career Centres (MCCs); (iv) Employees' Pension Scheme (EPS), 1995 implemented through EPFO;(v) Pradhan Mantri Shram Yogi Maandhan (PMSYM), a voluntary contributory scheme with matching contribution by Government of India for old age pension; (vi) Rehabilitation of Bonded Labourers for identification and rehabilitation of bonded labourers; (vii) health services through Employees State Insurance Corporation.

Details of expenditure under major schemes and number of beneficiaries, including in the State of Maharashtra, are Annexed.

Challenges in implementation of the schemes, such as awareness building and mobilisation of beneficiaries, are addressed through State Governments and local authorities, by organizing awareness camps, facilitating enrolment etc.

1. PRADHAN MANTRI SHRAM YOGI MAANDHAN (PM-SYM) PENSION SCHEME:

As on 16.07.2024, more than 50 lakh beneficiaries have been enrolled on Maandhan portal under PMSYM scheme including 6,10,368 beneficiaries in the State of Maharashtra.

2. LABOUR WELFARE SCHEME (LWS):

Year	Expenditure (Rs. in Crore)

2022-23	80.79
2023-24	81.31

The total beneficiaries during 2021-22, 2022-23 and 2023-24 are 62,47,409, out of which beneficiaries in Nagpur region (which includes Maharashtra, Goa, Dadra and Nagar Haveli and Daman & Diu) are 3,23,080.

3. National Career Service (NCS):

2022-23	43.99
2023-24	46.90

Jobseekers / beneficiaries under NCS during above three financial years are 2,16,44,766, out of which 17,79,443 are in the State of Maharashtra. So far, 28 Model Career Centers (MCCs) have been approved in the State of Maharashtra.

4. Aatmanirbhar Bharat Rojgar Yojana (ABRY):

2023-24	162.70

So far as on 31.03.2024, beneficiaries are 60.49 lakh, out of which 9.79 lakh beneficiaries are in the State of Maharashtra.

- **Employees State Insurance Corporation (ESIC):** Under the ESIC scheme, in the State of Maharashtra, there are 15 hospitals and 108 dispensaries; and in-principle approval for 19 new hospitals and 88 new dispensaries have been given. There are 44.55 lakh Insured Persons and 1.73 crore beneficiaries in the State.
- **Rehabilitation of Bonded Labour Scheme:** This scheme is demand driven where funds are provided to States / UTs on receipt of proposals from them. During last three years, this Ministry has not received any such proposal from Government of Maharashtra.
