SAKSHAM ANGANWADI AND POSHAN 2.0

2031 SHRI SURESH KUMAR SHETKAR:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether various schemes of the Ministry for maternal and child care are proposed likely to be brought under one comprehensive programme for synergy in implementation and also expedite upgradation of anganwadi centres under "Saksham Anganwadi and Poshan 2.0" for improved nutrition delivery, early childhood care and development;
- (b) if so, the details thereof and the progress made in this regard till date along with the list of beneficiaries, State wise hospital/anganwadi centre-wise; and
- (c) the steps taken/proposed to be taken to achieve the goal of Viksit Bharat 2047 under the said scheme?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI ANNPURNA DEVI)

(a) to (c) In the 15th Finance Commission, components of nutritional support for children below the age of 6 years, pregnant women and lactating mothers, Adolescent Girls (14-18 years in all aspirational districts and all districts of North Eastern States); Early Childhood Care and Education (ECCE) [3-6 years age]; Anganwadi infrastructure including modern, upgraded Saksham Anganwadi have been reorganised under Mission Saksham Anganwadi and Poshan 2.0 (Mission Poshan 2.0) for effective implementation of the scheme and for better nutritional delivery to end beneficiaries. Mission Poshan 2.0 seeks to address the challenge of malnutrition through improved nutrition content and delivery. It is a Centrally Sponsored Scheme, where the responsibility of implementation and administration of the scheme is under the ambit of States/UTs.

Under Mission Poshan 2.0, 2 lakh Anganwadi Centres (AWCs) @ 40,000 AWCs per year are to be upgraded as Saksham Anganwadis for improved nutrition delivery and for early childhood care and education (ECCE). Saksham Anganwadis are to be provided with infrastructure better than the conventional Anganwadi Centres including internet/Wi-Fi connectivity through Bharat Net (wherever possible), LED screens, water purifier/installation of RO Machine, Poshan Vatika, ECCE books and learning material etc. A total of 92108 AWCs have been approved for upgradation to Saksham AWCs across the country. The State wise year wise list of Anganwadi Centres approved for upgradation into Saksham Anganwadi is placed at **Annexure I.** In addition to this, State wise list of beneficiaries registered under the Mission Saksham

Anganwadi and Poshan 2.0 as per Poshan Tracker data as on 30.06.2024 is placed at **Annexure II.**

In order to fulfil the aim of Viksit Bharat 2047, under Mission Poshan 2.0 a strategic shift has been made to reduce malnutrition and for improved health, wellness and immunity through community engagement, outreach, behavioural change, and advocacy. The scheme focuses on Maternal Nutrition, Infant and Young Child Feeding Norms, treatment of Severe Acute Malnutrition (SAM)/ Moderate Acute Malnutrition (MAM) and wellness through AYUSH practices to reduce wasting, underweight prevalence, stunting and anaemia.

Under this scheme, Supplementary Nutrition is provided in accordance with the nutrition norms contained in Schedule-II of the National Food Security Act, 2013. To address the challenge of malnutrition more effectively, these nutrition norms have been revised in January, 2023. The old norms were largely calorie-specific; however, the revised norms are more comprehensive and balanced in terms of both quantity and quality of supplementary nutrition based on the principles of diet diversity that provides quality protein, healthy fats and micronutrients.

Under Mission Poshan 2.0, one of the major activities is Community Mobilization and Awareness Advocacy leading to Jan Andolan to educate the people on nutritional aspects. State and UTs are conducting and reporting regular sensitisation activities under community engagement programmes during Poshan Maahs and Poshan Pakhwadas celebrated in the months of September and March-April respectively. Community Based Events (CBEs) have served as a significant strategy in changing nutrition practices and all Anganwadi workers are required to conduct two Community Based Events every month.

Ministry of Women & Child Development and Ministry of Health & Family Welfare have jointly released the protocol for Community Management of Malnutrition (CMAM) to prevent and treat severe acute malnutrition in children and for reducing associated morbidity and mortality.

The Ministry of Health and Family Welfare (MoHFW) is implementing Reproductive, Maternal, Newborn, Child, Adolescent Health and Nutrition (RMNCAH + N) strategy under National Health Mission (NHM) to improve maternal and child health outcomes based on the Annual Program Implementation Plan (APIP) submitted by States / UTs.
