### 2045. SHRI CHANDRA PRAKASH CHOUDHARY:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether Ayushman Bharat has been a very ambitious scheme, if so, the details thereof;
- (b) the details of the people who have been registered/benefited under the scheme, State/ UTwise and district-wise including Bokaro, Dhanbad, Giridih districts of Jharkhand;
- (c) the diseases covered under the said scheme; and
- (d) the details of the expenditure incurred on Ayushman cards across the country, State/UT-wise?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI PRATAPRAO JADHAV)

- (a): Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) is the largest publicly funded health assurance scheme in the world, which provides health cover of Rs. 5 lakhs per family per year for secondary and tertiary care hospitalization to approximately 55 crore beneficiaries corresponding to 12.34 crore families, constituting the bottom 40% of India's population. States/UTs implementing AB-PMJAY have further expanded the beneficiary base at their own cost.
- (b): As on 30.06.2024, more than 34.7 crore Ayushman cards have been created and a total number of 7.37 crore hospital admissions worth Rs. One lakh crore have been authorised under the scheme. State/UT-wise details of number of Ayushman cards created are at **Annexure-I**. District-wise details of number of Ayushman cards created and hospital admissions authorised for the State of Jharkhand are at **Annexure-II**.

- (c): The scheme provides cashless healthcare treatment related to secondary and tertiary care ailments. The latest version of the national Health Benefit Package (HBP) master under AB-PMJAY provides for treatment corresponding to a total of 1,949 procedures under 27 different specialties including chronic diseases such as Cancer, Diabetes, Heart Disease and other non-communicable diseases. Under the scheme, States have been provided flexibility to further customise the Health Benefit Packages as per local requirement.
- (d): As on 30.06.2024, a total number of 7.37 crore hospital admissions worth Rs. One lakh crore have been authorised under the scheme. The State/UT-wise details of authorized hospital admissions under the scheme are at **Annexure-III**.
