Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether the Government has discontinued the salary component for programme officers of Child Development Project and Integrated Child Development Scheme Supervisors and Statistical officers, if so, the details thereof;
- (b) whether any amount is to be released to the State of Kerala in this regard, if so, the details thereof;
- (c) whether the salary component have been diverted for training and equipment purposes;
- (d) if so, the details of the utilization of these funds; and
- (e) whether States are already equipped with necessary equipment like computers, if so, whether the Union Government proposes to provide the same for salary?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI ANNPURNA DEVI)

(a) to (e): Government of India has discontinued the salary component of District Programme Officer and Statistical officer at District level, Child Development Project Officer and Statistical officer at project level and Supervisor from financial year 2023-24 onwards except for North Eastern and Himalayan States. The savings accrued on account of discontinuation of salary component was allocated to training component, provision of one computer alongwith printer-cum-scanner and uninterruptible power supply(UPS) at State/District/Project level, enhancement of cost of pre-school education from Rs. 1000/- to Rs. 3000/- per AWC, enhancing the allocation of petrol, oil, lubrication(POL)/Hiring of vehicle to Rs. 4.50 lakh per annum and for procurement of equipment and furniture. The details of fund released during financial year 2023-24 for these components are placed at **Annexure**.
