CENTRAL ADVISORY BOARD ON ARCHAEOLOGY

2171. Dr. T SUMATHY ALIAS THAMIZHACHI THANGAPANDIAN:

Will the **Minister of CULTURE** be pleased to state:-

- a) whether the Government has reconstituted the Central Advisory Board on Archaeology (CABA) in 2022, seven years after its last meeting, if so, the details thereof and the present composition and members of the CABA;
- b) whether the Government has taken appropriate measures to excavate and publish the archaeological sites in Tamil Nadu State during the last ten years and if so, the details thereof;
- c) the total number of Sanctioned posts, present status, vacant posts of Directors, Superintending Archaeologists, Deputy SAs, Assistant Archaeologists, Superintending Epigraphists, Deputy Superintending Epigraphists, Assistant Epigraphists, Conservation Assistants, Curators all Class A,B,C and D employees in Archaeological Survey of India (ASI); and
- d) whether the Government has initiated any special recruitment drive for filling up of vacancies in SC/ST/OBC and Minority communities in ASI and if so, the details thereof, if not, the reasons therefor?

ANSWER

- (a) Yes Sir. Notification was published in The Gazette of India on 19th May 2022.
- (b) Yes Sir. Archaeological Survey of India (ASI) conducts excavations all over the country including Tamil Nadu. Sites excavated in Tamil Nadu during the last 10 years are listed in Annexure I.
- (c) The details are provided in Annexure II.
- (d) The vacancies which include SC/ST/OBC and Minority Communities falling under Direct Recruitment Quota are reported from time to time to the Recruitment agencies i.e., UPSC and SSC.
