**IMPLEMENTATION OF NATIONAL APPRENTICESHIP PROMOTION SCHEME (NAPS)
IN JHARKHAND**

Will the MINISTER OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state :

- (a) whether the Government has implemented the National Apprenticeship Promotion Scheme (NAPS) in Jharkhand State, and if so, the details thereof;
- (b) whether the Government has set any target under NAPS for Jharkhand, including the number of apprentices to be trained and industries to be covered, if so, the details thereof;
- (c) the amount of funds allocated and utilized for NAPS in Jharkhand during the last three years;
- (d) the details and number of apprentices trained under the NAPS in Jharkhand, and its impact on their employability; and
- (e) whether the Government has any future plans for expanding and enhancing the effectiveness of NAPS in Jharkhand?

ANSWER

(a) Yes, Sir. Government of India has implemented the National Apprenticeship Promotion Scheme (NAPS) across the country, including Jharkhand. The number of trained candidates under NAPS in Jharkhand From FY 2018-19 to 30th June 2024 is given below :

(b) Government of India has set target of engaging 12,00,000 apprentices under NAPS across the country including Jharkhand for FY 2024-25. During the current FY 2024-25 till 30th June, 2024 a total No. of 1,356 apprentices in 194 establishments have been trained in Jharkhand.

(c) The amount of funds allocated/utilized for NAPS in Jharkhand during the last three years is as follows :

- (i) Launch of Direct Benefit Transfer
- (ii) Pradhan Mantri National Apprenticeship Mela (PMNAM) and Apprenticeship Awareness Workshops
- (iii) Enhanced Participation of Women
- (iv) Continuous focus-driven approach with State Authorities/Central public sector units
- (v) Increased Industry participation and Cluster-based approach
- (vi) Portal Simplification measures enabling ease of doing business.
