LOK SABHA UNSTARRED QUESTION NO. 222 ANSWERED ON 22.07.2024 Mismanagement in Conducting Exams by NTA

222. SMT. KANIMOZHI KARUNANIDHI: DR. RANI SRIKUMAR:

Will the Minister of EDUCATION be pleased to state:

- (a) the details of exams that have been postponed by National Testing Agency (NTA) from its scheduled date notified in the official notification during the last seven years, year-wise;
- (b) the reasons for postponing many exams and the measures taken by the NTA to prevent such postponing;
- (c) whether the NTA is aware of the complaints raised by students regarding the centres being allotted in far-away places and inadequate infrastructures in centres for differently-abled people;
- (d) if so, the details thereof; and
- (e) if not, the grievance redressal mechanisms put in place to raise complaints?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (DR. SUKANTA MAJUMDAR)

(a) & (b) Since its inception in 2018, NTA has successfully conducted over 240 examinations involving over 5.4 crores students.

Since most of the examinations conducted by NTA are held in multiple-subjects, multiple-shifts and span over a number of days, there have been instances due to unforeseen circumstances like COVID-19 pandemic, logistical and technical issues, administrative issues, legal orders etc, when examination dates initially notified in respect of specific subjects/shifts could not be adhered to.

The Examinations as a whole have been postponed in some cases, list of which is enclosed as **Annexure**.

NTA has started declaration of Examination Calendar of major examinations, much in advance for the facilitation of candidates. The Examination calendar is planned taking into consideration, buffer days to accommodate for reschedules/postponements for reasons beyond the control of NTA.

(c) to (e) Centres are allotted to candidates through Computer Software as per City preference and availability of capacity in each centre. Efforts are made to allot centres in one of the city choices filled-in by the candidates. However, when the number of candidates is very large, some candidates may not be accommodated in cities opted by them. In such cases, NTA tries to accommodate them in nearby places. While allocating centres to differently-abled candidates, due care is taken to ensure that infrastructure is Divangjan friendly.

Complaints/Grievances of candidates are received through e-mails and Help Desk phone numbers. The same are resolved in a systematic manner.
