LAUNCH OF SPECIAL SKILL DEVELOPMENT AND ENTREPRENEURSHIP PROGRAMME IN GUJARAT

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) whether the Government is running or proposes to launch any special skill development and entrepreneurship programmes in Gujarat State for the special needs of the youth, particularly those living below poverty line and among marginalized section in Gujarat with regard to Bhuj, Abdasa, Gandhidham, Rapar, Mandvi and Anjar districts particularly of Kachchh Lok Sabha Constituency in the State of Gujarat, if so, the details thereof;
- (b) whether the said programmes are linked with job placement;
- (c) if so, the details thereof indicating the jobs provided thereunder; and
- (d) if not, the reasons therefor?

ANSWER

(a) to (d) Under the Government of India's Skill India Mission (SIM), the Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill, re-skill and up-skill training through an extensive network of skill development centres/ institutes etc. under various schemes, viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs), to all the sections of the society including those living Below Poverty Line (BPL) and marginalized section across the country including the cities of Bhuj, Abdasa, Gandhidham, Rapar, Mandvi and Anjar of Kachchh District, Gujarat.

The number of beneficiaries covered under the schemes of MSDE in Kachchh District is as under:

Among the schemes of MSDE, placements were specifically tracked only in the Short Term Training (STT) component of PMKVY in the first three versions i.e., PMKVY 1.0, PMKVY 2.0 and PMKVY 3.0 of the scheme implemented from FY 2015-16 to FY 2021-22. Placement is de-linked from PMKVY 4.0, the current version of the scheme under implementation from FY 2022-23, onwards. The total number of persons placed in Kachchh District in the STT component of PMKVY during FY 2015-16 to FY 2021-22 is 3,372.
