ANNAPURNA SCHEME

2304 SHRI K C VENUGOPAL:

Will the Minister of RURAL DEVELOPMENTbe pleased to state:

- (a) the total funds and foodgrains allocated under the Annapurna Scheme to various Statesincluding Kerala during the last five years;
- (b) whether the Government has noted that the targeted number of beneficiaries under theAnnapurna Scheme is declining periodically in States like Kerala and if so, the details thereof;
- (c) whether receiving an old age pension is a hurdle for availing benefits under the AnnapurnaScheme;
- (d) whether the Government is considering for easing the criteria in light of this situation and ifso, the details thereof;
- (e) whether the Government released foodgrains under welfare schemes to beneficiariesliving in old age homes and orphanages in Kerala during the last quarter; and
- (f) if so, the details thereof and if not, the reasons therefor?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI KAMLESH PASWAN)

(a): Funds allocated under the Annapurna Scheme to various States/UTs including Kerala for providing the prescribed quantity of food grains (10 kgs of food grains (wheat or rice) per month per beneficiary) during last five years is at Annexure-I. Year-wise details of allocation of foodgrains by Department of Food and Public Distribution against the compiled requirement of foodgrains under Annapurna received from the States/UTs is given in Annexure-II. (b): Annapurna Scheme is a demand based sub-scheme of National Social Assistance Programme (NSAP). With the implementation of National Food Security Act, 2013, the lifting of food grains under the Annapurna scheme has shown a declining trend since 2016-17 and has been "Nil" since FY 2020-21 in respect of States including Kerala.

(c) & (d): No. Annapurna scheme was aimed at providing food security to meet the requirement of those senior citizens who, though eligible, have remained uncovered under the old age pension scheme under NSAP.

(e) & (f): As informed by Department of Food and Public Distribution, Government is allocating foodgrains on half-yearly basis to States/UTs under Welfare Institution and Hostels Schemes (WI&HS) for the residents of SC/ST/OBC hostels and welfare institutions viz. charitable institutions such as beggar homes, Nari-niketans and other similar welfare institutions that are not covered under Targeted Public Distribution System (TPDS) or any other welfare scheme. Under the said scheme, the Department of Food and Public Distribution had last allocated 3,387.06 MT of food grains for 37,634 beneficiaries to the Government of Kerala for the period of April, 2024 to September, 2024. No other request for allocation of foodgrains under WI&HS has been received from Government of Kerala thereafter.
