(a) the details of the various types of textiles products imported and exported by India during the last five years, year and country-wise;

(b) the details of the revenue earned through export of Indian Textiles during the last five years;

(c) the measures being taken by the Government to make the textiles produced in India more competitive and profitable to the producers;

(d) whether the Government has launched any scheme to provide better production facilities to the textiles producers of the country; and

(e) if so, the details thereof?

(a) & (b): The details of India's export and import of Textiles & Apparel (including handicrafts) during the last 5 years is placed at Annexure.

(c) to (e): In order to boost export of textiles products, Government is implementing scheme for Rebate of State and Central Taxes and Levies (RoSCTL) on exports of Apparel/Garments and Made-ups. Further, textiles products not covered under the RoSCTL are covered under Remissions of Duties and Taxes on Exported Products (RoDTEP) along with other products.

Government is implementing various schemes viz, Pradhan Mantri Mega Integrated Textile Region and Apparel (PM MITRA), SAMARTH (Scheme for Capacity Building in Textile Sector), Silk Samagra, National Handloom Development Programme, National Handicraft Development Programme, Integrated Wool Development Programme (IWDP), National Technical Textile Mission (NTTM), etc. catering exclusively for development of textile sector in the country. Further, Government is promoting production of MMF Apparel, MMF Fabrics and Products of Technical Textiles in the country through Production Linked Incentive (PLI) Scheme for Textiles.
