IMPLEMENTATION OF PM-MITRA SCHEME

2368. SHRI KRISHNA PRASAD TENNETI:

Will the Minister of TEXTILES वस्त्र मंत्री be pleased to state :

- (a) whether the Government has conducted any survey/study/research into the implementation of Government schemes such as PM-MITRA scheme pertaining to integrated textile parks and if so, the details thereof;
- (b) the details regarding the total number of integrated textile parks completed, under progress and proposed to be set up over the last five years, State-wise especially in Andhra Pradesh;
- (c) the details regarding the funds allocated and utilised for the purposes of setting up textile parks during the last five years, State-wise especially in Andhra Pradesh and Bapatla district; and
- (d) the details regarding the total number of beneficiaries of above schemes pertaining to integrated textile parks across the country during the last five years, State-wise especially in Andhra Pradesh?

उत्तर ANSWER वस्त्र राज्य मंत्री (**श्री पबित्र मार्घेरिटा**) THE MINISTER OF STATE FOR TEXTILES (SHRI PABITRA MARGHERITA)

- (a): The Government has approved setting up of 7 (Seven) PM Mega Integrated Textile Region and Apparel (PM MITRA) Parks in Greenfield/Brownfield sites with world class infrastructure including plug and play facility with an outlay of Rs. 4,445 cr for a period of seven years upto 2027-28. Since the scheme is at an initial stage of implementation, therefore no survey/study/research has so far been conducted. Apart from this, Ministry is also implementing Scheme for Integrated Textile Park (SITP) to provide support for setting up textile parks with world-class, state-of-the-art infrastructure in textile hubs across the country. Under SITP, out of 50 textile parks sanctioned, 30 textile parks have been completed while 20 textile parks are under implementation. An evaluation study of SITP was carried out by Arun Jaitley National Institute of Financial Management (AJNIFM) in December 2020. The study inter alia indicated that the SITP generated employment, attracted investment and augmented development of infrastructure.
- **(b) to (d):** Details of textile parks under SITP, completed and under implementation, funds released and employment generated during last five years is as under;

No textile park under SITP has been sanctioned in Bapatla district Andhra Pradesh in the last five years. However, four textile Parks viz. Brandix India Apparel City Pvt. Ltd, Hindupur Vyapar Apparel Park Ltd, Tarkeshwara Textile Park and Guntur Textile Park have been sanctioned to Andhra Pradesh under the SITP Scheme. No proposal from Andhra Pradesh for setting up of SITP Park is pending in the Ministry.
