Will the Minister of COMMERCE & INDUSTRY (वाणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) the details and the list of the countries to which the export of non-basmati white rice is presently allowed;
- (b) the total quantity of non-basmati white rice exported from the country during the last three years and the current year;
- (c) whether there is any proposal under consideration of the Government for a complete removal of the ban on non-basmati rice exports; and
- (d) if so, the details thereof?

(a) Export policy of Non-Basmati White Rice under HS Code 1006 30 90 (Semi-milled or wholly milled rice, whether or not polished or glazed: Other) has been amended from 'free' to 'Prohibited' vide DGFT Notification No. 20/2023 dt. 20.07.2023, however, export will be allowed on the basis of permission granted by Govt. of India to other countries to meet their food security needs and based on the request of their government. Accordingly, Export of non-basmati white rice has been allowed to the following countries with respective quantities under G2G arrangement:
