### ONE NATION ONE RATION CARD

### 250 SHRI JANARDAN SINGH SIGRIWAL:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) whether the Government has launched One Nation One Ration Card (ONORC) plan in the country;
- (b) if so, the salient features thereof;
- (c) the number of Ration Card holders in the country, State-wise including Bihar;
- (d) the number of ration card holders whose ration card have been linked with Aadhaar, State-wise including Bihar; and
- (e) the status of supply of food grains to these card holders under the ONORC scheme, State-wise including Bihar?

#### ANSWER

# MINISTER OF STATE FOR MINISTRY OF CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION

### (SHRIMATI NIMUBEN JAYANTIBHAI BAMBHANIYA)

(a) and (b): Yes, The nationwide portability of ration cards, popularly known as One Nation One Ration Card (ONORC) has been implemented in all 36 States/UTs. After the successful implementation of the end-to-end computerisation of Public Distribution System (PDS) operations in all States/UTs significant progress has been achieved in the realms of digitization of ration cards, computerisation of supply chain management, installation of electronic Point of Sale (ePoS) devices at Fair Price Shops(FPS) across the country, availability of online grievance redressal systems, transparency portals in all States/UTs etc. Buoyed by the technological progress, the Department initially implemented One Nation One Ration Card (ONORC) plan in August 2019 with 4 states and by the end of June 2022, it was operational across all 36 States/UTs of the country. Since its inception more than 144 Crore portability transactions have been recorded under the ONORC plan, which includes both inter-State and intra-State transactions, ensuring the food security of more than 80 Crore National Food Security Act 2013 (NFSA) beneficiaries in the country.

ONORC initiative is proving to be beneficial especially to the migrant labourers, internally displaced persons (IDPs) etc. who frequently change their place of dwelling in search of temporary employment. Under the initiative, the NFSA beneficiaries are empowered to lift their entitled foodgrain from any Fair Price Shop (FPS) of their choice, anywhere in the country, by using their existing ration card/Aadhaar card with biometric authentication on an electronic Point of Sale (ePoS) device. ONORC also enables the family members of such migrant NFSA beneficiaries to lift the part / balance foodgrains on the same ration card, back home (in the village/hometown).

Further, ONORC has also facilitated the migrant beneficiaries/ family members to choose any Fair Price Shop of their choice without being dependent on visiting only the tagged FPS in their ration cards. Such flexibility was not available earlier under the traditional PDS.

- (e): State-wise status of supply of food grains to NFSA cardholders under the ONORC scheme, including Bihar, since inception in August 2019 to July 2024 is attached as **Annexure-II.**\*\*\*\*\*
