## **Accidents in Singrauli Coal Mines**

## †2571. Ms Iqra Choudhary:

Will the Minister of **COAL** be pleased to state:

- (a) whether several contract workers lost their lives in accidents caused due to negligence of officials in NCL Singrauli (Madhya Pradesh) under Coal India Limited during the last three years;
- (b) if so, the details thereof;
- (c) the details of assistance provided to each deceased and injured person by the Government/ Coal India Limited in every cases;
- (d) whether any investigation was conducted by the Director (Safety) labour regarding these accidents; and
- (e) if so, the outcome thereof and the details of action taken against the guilty officers?

# ANSWER MINISTER OF COAL AND MINES (SHRI G. KISHAN REDDY)

- (a): The causes of accidents for contractual workers in respect of Northern Coalfields Limited (NCL), under Coal India Limited (CIL), who lost their lives during last three years are mainly due to collision of tippers, hit by object, fall of persons and toppling of tippers.
