#### ONE DISTRICT ONE PRODUCT INITIATIVE UNDER PMFME SCHEME IN BIHAR

#### 2762. DR. MOHAMMAD JAWED:

#### Will the *MINISTER OF FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) the manner in which the Government is promoting One District One Product (ODOP) initiative under the Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) scheme to enhance food processing and market reach in Bihar, particularly in district Kishanganj;
- (b) the steps taken/being taken by the Government under the said scheme to identify and support unique food products from various districts in Bihar, particularly from Kishanganj district;
- (c) the manner in which the Government ensures equitable distribution of funds and resources for promoting ODOP projects under the said scheme in various districts of Bihar including Kishanganj district; and
- (d) the specific criteria or eligibility requirements to be selected under the ODOP initiative of the said scheme for various districts in Bihar, particularly for Kishanganj district?

#### **ANSWER**

# THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

(a). Under One District One Product (ODOP) initiative under the Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) scheme, ODOP have been identified in 726 districts of 35 States/ UTs in the country. For the State of Bihar, ODOP has been identified for all the 38 districts including pineapple-based products for the district of Kishanganj. The district wise list of ODOP for the State of Bihar is at **Annexure-I**.

Further, 15,207 loans for credit linked subsidy have been sanctioned to micro food processing enterprises based on ODOP products, 76 ODOP based Incubation Centres have been approved and 15 brands of ODOP products have been launched for marketing and branding support to Micro food processing units in the country. In the State of Bihar, 14,444 loans have been sanctioned out of which 210 loans have been sanctioned in Kishanganj district.

- (b). The following support is provided under PMFME Scheme in the country including State of Bihar:
  - (i). Support to Individual / Group Category Micro Enterprises: Credit-linked capital subsidy @35% of the eligible project cost, maximum ceiling Rs.10 lakh per unit;

- (ii). Support to SHGs for seed capital: Seed capital @ Rs. 40,000/- per member of SHG engaged in food processing for working capital and purchase of small tools subject to maximum of Rs. 4 lakhs per SHG Federation.
- (iii). Support for Common Infrastructure: Credit linked capital subsidy @35% subject to maximum of Rs. 3 crores to support FPOs, SHGs, Cooperatives and any Government agency for setting up of common infrastructure.
- (iv). Branding and Marketing Support: Grant upto 50% for Branding and Marketing to groups of FPOs/ SHGs/ Cooperatives or an SPV of micro food processing enterprises.
- (v). Capacity Building: The scheme envisages training for Entrepreneurship Development Program (EDP) to meet the requirement of food processing industry and product specific skilling.

For the State of Bihar, 25 unique ODOP products have been identified and support under PMFME Scheme as per the details at **Annexure-II**.

- (c). Till 30<sup>th</sup> June 2024, Centre share amount of Rs. 115.78 Cr. has been released to the State of Bihar for implementation of various components of the PMFME Scheme including setting up / upgradation of micro food processing enterprise based on ODOP. MoFPI is taking various initiatives to promote and increase awareness & participation among beneficiaries through National & State level awareness campaigns such as Newspaper advertisement, Radio Jingles, Exhibitions & Expos, Millet Fairs, Buyer-Seller Meets etc. since the inception of the scheme.
- (d). ODOP under PMFME Scheme have been notified based on agriculture production, presence of micro-food processing enterprises, SHGs/FPOs/Cooperative/micro-enterprises engaged in processing of ODOP, etc. on the recommendations of the respective State/UT government and also in consultation with the Ministry of Agriculture & Famers Welfare.
