**City Gas Distribution Projects in Rajasthan**

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether the Government proposes to ensure consumption of gas produced in Rajasthan locally by developing city gas distribution projects in 20 districts falling under 11 notified geographical areas in the State;
- (b) if so, the details thereof;
- (c) if not, the reasons therefor; and
- (d) the names of the cities and villages of Rajasthan where gas is being supplied through pipeline at present and the relevant details thereof?

(a) to (d) Government allocates domestic Administered Pricing Mechanism (APM) gas for supply to all Geographical Areas (GAs) authorized by PNGRB. Gas produced from fields across the country form part of national resource which is suitably allocated as per the Government policy on commercial utilization of natural gas. Providing Piped Natural Gas (PNG) connections and establishment of Compressed Natural Gas (CNG) stations, are part of development of City Gas Distribution (CGD) network and the same is carried out by the entities authorized by the Petroleum and Natural Gas Regulatory Board (PNGRB). After completion of 12/12A CGD bidding round, PNGRB has authorised 17 Geographical Areas (GAs) (including 2 GA spread over Madhya Pradesh and Rajasthan & 1 GA spread over Uttar Pradesh & Rajasthan) covering all the districts in the state of Rajasthan. As on 31.05.2024, the entities have provided approx 3.51 lakh PNG (Domestic) connections and 26,462 Inch-kilometer of Steel and MDPE pipeline has been laid to households across various GAs in the State.
