EKLAVYA MODEL RESIDENTIAL SCHOOLS

2787 SHRI LAVU SRI KRISHNA DEVARAYALU:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the current status of infrastructure development in Eklavya Model Residential Schools (EMRS) in Andhra Pradesh, district-wise;
- (b) the details of any ongoing construction or renovation projects and the timeline for their completion;
- (c) whether the shortage of qualified teachers and support staff in EMRS in Andhra Pradesh has been looked into by the Government;
- (d) if so, the details thereof; and
- (e) if not, the present number of teachers in each Eklavya Model Residential Schools in the State of Andhra Pradesh, district-wise?

ANSWER

(a) and (b): Ministry of Tribal Affairs sanctioned a total number of **28** Eklavya Model Residential Schools (EMRSs) [14 under Article 275(1) of the Constitution of India and 14 under new scheme] in the State of Andhra Pradesh. The construction work of 19 EMRSs has been completed, 8 EMRSs is in progress and 01 EMRS is at pre-construction stage. Additionally, Ministry has decided to provide Rs.5 cr per EMRS for upgradation of the EMRSs sanctioned under Article 275(1). Accordingly, National Education Society for Tribal Students (NESTS), the autonomous body under the Ministry to manage and implement the scheme of EMRS, has approved proposals for upgradation of 11 EMRSs sanctioned in Andhra Pradesh, out of which upgradation work of 02 schools has been completed and of 09 schools is in progress. District/ location-wise status of infrastructural development of EMRSs in Andhra Pradesh is at **Annexure**.

(c) to (e): Department of Expenditure, Ministry of Finance approved creation of 38,480 posts for teaching and non-teaching staff for EMRSs across the country advising to make the recruitment to fill these posts in a phased manner from 2022-23 to 2026-27. Accordingly, NESTS has initiated the centralized recruitment in the year 2023. As reported by NESTS, the recent centralised recruitment in EMRSs across the country (including Andhra Pradesh) has enabled the appointment of over 8000 teaching and non-teaching staff, thereby supporting the mandate of Government to provide quality education to the students of EMRSs.

As reported by NESTS, the State of Andhra Pradesh submitted the vacancy position of teaching and non-teaching staff in EMRS as 783, out of which 555 number of posts have been filled.
