FREE COACHING FOR SCHEDULED TRIBE STUDENTS

Will the Minister of TRIBAL AFFAIRS be pleased to state:

(a) whether a number of schemes have been proposed/implemented by the Government to provide free coaching to tribal students for preparation of Competitive Examinations in the country and if so, the details thereof;

(b) whether free coaching for preparation of IITs and UPSC examinations have also been provided free of cost to tribal students under the said scheme and if so, the details thereof;

(c) whether the Government proposes to provide free of cost quality coaching to the candidates belonging to the deprived Scheduled Tribes (STs) so as to enable them to qualify the competitive examinations to get jobs in Public/Private Sector and if so, the details thereof; and

(d) whether the students/candidates belonging to the poor Scheduled Tribes (STs) under Ramanuganj-Balrampur and Surajpur districts in Sarguja Parliamentary Constituencies in the State of Chhattisgarh are likely to be benefited by the said scheme and if so, the details thereof?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI DURGADAS UIKEY)

(a) to (d): Ministry of Tribal Affairs is not administrating any exclusive scheme for providing coaching to Scheduled Tribe students. However, Ministry of Tribal Affairs provides financial assistance to the State Governments on the basis of their proposals under Grants under Proviso to Article 275(1). Details of funds approved for activities of coaching for STs under Proviso to Article 275(1) during 2019-20 to 2023-24 are as under:

Further, under the erstwhile scheme 'Special Central Assistance to Tribal Sub-Scheme', Ministry of Tribal Affairs has provided funding on the proposal received from the State Governments. Besides this, Ministry of Tribal Affairs under scheme of "Development of PVTGs" for socioeconomic and holistic development of PVTGs, provided funds to the concerned State Government / UT for activities of coaching for PVTG students as given below.
