PMKSY IN ANDHRA PRADESH

Will the Minister of **JAL SHAKTI** be pleased to state:

- (a) the aims and objectives of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY);
- (b) whether the funds have been released to Andhra Pradesh and Uttar Pradesh under the yojana during the last four years and the current year;
- (c) if so, the details thereof, year-wise; and
- (d) the details of projects that have been undertaken under Command Area Development and Watershed Management (CADWM) and subsequently under PMKSY since 2014 when State of Andhra Pradesh was bifurcated along with status of each such projects?

ANSWER

(a) Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) was launched during the year 2015-16, with an aim and objective to enhance physical access of water on farm and expand cultivable area under assured irrigation, improve on-farm water use efficiency, introduce sustainable water conservation practices, etc. Under PMKSY, various measures for creation of assured irrigation source, construction of diversion canals, field channels, water diversion/lift irrigation, including development of water distribution systems are undertaken.

PMKSY is an umbrella scheme, consisting of two major components being implemented by Ministry of Jal Shakti, namely, Accelerated Irrigation Benefit Programme (AIBP), and Har Khet Ko Pani (HKKP). HKKP, in turn, consists of Command Area Development and Water Management (CADWM), Surface Minor Irrigation scheme (SMI), Repair-Renovation-Restoration of water bodies (RRR), and Ground Water Management. However, Ground Water Management has been since discontinued.

In addition, Watershed Development component (WDC) of PMKSY is being implemented by Department of Land Resources. Further, Per Drop More Crop (PDMC) was implemented by Department of Agriculture and Farmers Welfare (DoA& FW) under the umbrella of PMKSY during 2016-22, which is now being implemented by DoA& FW under Rashtriya Krishi Vikash Yojana (RKVY).

(b) & (c) Details of funds released to Andhra Pradesh and Uttar Pradesh under the PMKSY during the last four years and the current year, year-wise, are tabulated below:

(d) After launch of PMKSY in 2015-16, 7 number of projects from the State of Andhra Pradesh have been included for partial financial assistance under Command Area Development and Water Management (CADWM) component of PMKSY-HKKP. Details in this regard are tabulated below.
