FOOD PROCESSING UNITS IN MAHARASHTRA

Will the *MINISTER OF FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) whether the Government has implemented a Centrally Sponsored Scheme namely Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) with an approach of 'One District, One Product (ODOP)' and if so, the details thereof;
- (b) the total number of Food Processing Units set up in the country so far under the said scheme, State-wise, particularly in Maharashtra;
- (c) the number of Food Processing Units set up for the SC/ST and OBC communities in the country, State-wise, particularly in Maharashtra;
- (d) whether the un-incorporated and unregistered food processing zones and units are functioning in the country and if so, the details thereof, State-wise, particularly in Maharashtra; and
- (e) the details of the Food Processing Units functioning at present along with the employment generated by them in the country, State-wise, particularly in Maharashtra?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

- (a). As a part of Atmanirbhar Bharat Abhiyan, Ministry of Food Processing Industries (MoFPI) is implementing a centrally sponsored "Pradhan Mantri Formalisation of Micro food processing Enterprises (PMFME) Scheme" for providing financial, technical and business support for setting up / up-gradation of micro food processing enterprises in the country. The scheme is operational for a period of five years from 2020-21 to 2024-25 with an outlay of Rs. 10,000 crores. Scheme adopts One District One Product (ODOP) approach to reap the benefit of scale in terms of procurement of inputs, availing common services and marketing of products. Ministry has approved ODOP for 726 districts in 35 States/ UTs across the country based on the recommendations of State / UT Governments and also in consultation with Ministry of Agriculture and Farmers Welfare.
- (b). Till 30th June 2024, 92549 loans have been sanctioned by lending Banks for credit linked subsidy for setting up / up-gradation of micro food processing enterprises under the scheme in the country including 17214 loans in the State of Maharashtra. The State-wise list of Food Processing Units is at **Annexure-I.**

- (c). Till 30th June 2024, State-wise details of loan sanctioned to SC/ ST/ OBC category for setting up / up-gradation of micro food processing enterprises under PMFME Scheme in the country including State of Maharashtra is at **Annexure-II**.
- (d). As per the 73rd round survey of National Sample Survey Office (NSSO), there are around 25 lakh unregistered/unincorporated food processing enterprises in the country including 2,29,372 enterprises in the State of Maharashtra. The State-wise details are at **Annexure-III**.
- (e). As per Annual Survey of Industries (2021-22), there are around 41,913 units engaged in Food Processing sector (registered and unincorporated sector) in the country including 2755 units in Maharashtra. The State-wise details are at **Annexure-IV**.
