- (a) the details of micro and small enterprises to which credit guarantee facility has been provided under the Credit Guarantee Scheme for Micro & Small Enterprises, State-wise;
- (b) the number of applications received for availing benefits under the said scheme i.e., CGTMSE from Uttar Pradesh, Madhya Pradesh and Odisha including Bhadohi, Jhansi, Dewas and Balasore Constituencies respectively along with the number of applications which have been sanctioned guarantees;
- (c) whether the Government has framed any guidelines which the lending institutions are required to adhere to while selecting beneficiaries under the said scheme; and
- (d) if so, the details thereof and if not, reasons therefor?

#### **ANSWER**

## MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

- (a): The State/UT-wise details of credit guarantee extended to Micro and Small Enterprises under the Credit Guarantee Scheme for Micro and Small Enterprises are given at Annexure I.
- (b): The details of guarantees approved under the Credit Guarantee Scheme for Micro & Small Enterprises in the States of Uttar Pradesh, Madhya Pradesh and Odisha are given in Annexure II. The details of guarantees approved for the districts of Bhadohi, Jhansi, Dewas and Balasore are given in Annexure III.
- (c) and (d): Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) extends guarantee coverage up to ₹5 Crore for the credit facilities extended to Micro and Small Enterprises by Member Lending Institution (MLI) without any collateral security and third-party guarantee. As per the information provided by CGTMSE it approves all the applications lodged by MLIs.
