2847. SMT. SANDHYA RAY:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the number of registrations received on the Udyam Assist Platform, State/UT-wise;
- (b) whether the Informal Micro Enterprises (IMEs) which register on the platform would be penalized for not having a GST Number;
- (c) whether the Udyam Assist Platform provides Priority Sector Lending (PSL) benefits to registered IMEs; and
- (d) if so, the details thereof and if not, the reasons therefor?

ANSWER

- (a): The State/UT-wise details of registration on Udyam Assist Platform (UAP), as on July 30, 2024, are given at Annexure.
- (b): UAP facilitates registration of Informal Micro Enterprises (IMEs) which are not covered under the GST regime. There is no provision of penalization of IMEs for not having a GST number.
- (c) and (d): Gazette Notification of Ministry of MSME S.O. 1296(E) dated March 20, 2023 states that the certificate issued on UAP to IMEs shall be treated at par with Udyam Registration Certificate for the purpose of availing Priority Sector Lending (PSL) Benefits. IMEs with an Udyam Assist Certificate shall be treated as micro enterprises for the purpose of PSL classification.
