2874. SHRI RAVINDRA DATTARAM WAIKAR:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS

be pleased to state:

- (a) the details and number of ongoing National Highways (NHs) projects in the country, State and location-wise, particularly in Maharashtra;**
- (b) whether the Government has set any time-limit for the construction of the said projects and if so, the details thereof, State and location-wise;**
- (c) the quantum of funds sanctioned, disbursed and utilised for the said projects, State and project-wise; and**
- (d) the details of new NHs (in kilometers) proposed to be constructed by the Government in the country, State and NH-wise?**

ANSWER

- (a) The State/Union Territory (UT)-wise details of ongoing National Highway (NH) projects in the country including in the State of Maharashtra is at Annexure-I.**
- (b) A time period of 2 ~ 3 years is generally considered for completion of a NH project from its Appointed / Commencement date.**
- (c) Allocation of funds for development of NHs are made State/Agency-wise and not project-wise. The State / UT - wise details of funds allocated and expenditure incurred for development**

and maintenance of NHs during the current financial year 2024-25 is at Annexure-II.

(d) A provisional target of about 10,400 km has been kept for construction of NHs during the current financial year 2024-25.
