2881. SHRI VISHWESHWAR HEGDE KAGERI:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS

be pleased to state:

- (a) whether any proposals are pending for the upgradation of SH-69 (Ekkambi to Tadas), SH-93 (Khanapur to Talguppa), SH-143 (Gokarna-Vaddi-Sirsi), SH-145 (Sonaginamane-Unchalli Falls) and SH-77 (Sirsi-Hosanagara) into National Highways (NHs) in Uttara Kannada district of Karnataka and if so, the details thereof;
- (b) the progress of the ongoing projects of NHs in the said district of Karnataka and the hurdles faced to complete the projects; and
- (c) the time by which the said projects are likely to be completed?

ANSWER THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS (SHRI NITIN JAIRAM GADKARI)

- a) The Ministry keeps on receiving proposals from various State Governments / Union Territories (UTs), including from the State Governments of Karnataka for declaration / upgradation of State roads as new NHs. The Ministry considers declaration of some State roads as NHs from time to time based on the fulfillment of the criteria for declaration of NHs, requirement of connectivity, inter-se priority and availability of resources.
- (b) to (c) The details of ongoing NH projects in Uttara Kannada district of Karnataka are at Annexure, along with scheduled / revised scheduled completion date.
