GRANTS UNDER ARTICLE 275(1) OF THE CONSTITUTION

2892 DR. DR JAYANTA KUMAR ROY:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether the Government provides funds to States under "Grants under Article 275(1) of the Constitution";
- (b) if so, the details thereof along with the amount of funds allocated during the last three years, State-wise and year-wise;
- (c) the details of development works done during the last three years, State-wise and year-wise;
- (d) whether the Government has received any complaint regarding any irregularities in the utilisation of the said funds; and
- (e) if so, the details thereof and the remedial measures taken/proposed to be taken thereon?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI DURGADAS UIKEY):

(a) to (c): Ministry of Tribal Affairs provides financial assistance to the State Governments on the basis of their proposals under Grants under Proviso to Article 275(1) of the Constitution. Funding under this program is to enable the State to meet the cost of such schemes of development as may be undertaken by the State for the purpose of promoting the welfare of Scheduled Tribes in that State which includes various sectors viz. (i) Education (ii) Health (iii) Agriculture, Horticulture, Animal Husbandry (AH), Fisheries, Dairy & others in Primary Sector (iv) Other income generating schemes to augment Tribal household economy and (v) Administrative structure / Institutional framework & Research studies or for raising the level of administration of the Scheduled Areas therein.

The details of funds released to the State Governments during last three years, State-wise and year-wise, under Proviso to Article 275(1) of the Constitution are at Annexure-I. The details of funds approved, sectorwise, for various development works/projects/activities to the State Governments during last three years under Proviso to Article 275(1) of the Constitution, State-wise and year-wise, are at Annexure-II.

- (d): No complaint regarding any irregularities in the utilisation of the said funds has been received.
- (e) In view of (d), does not arise.
