DEVELOPMENT OF CITIES IN RAJASTHAN**

**NO. 2957. SHRI UMMEDA RAM BENIWAL:**

**Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:**

- (a) the amount of funds sanctioned, allocated and utilised so far under various projects of Smart Cities Mission (SCM) in Rajasthan during the last five years, city, item and year-wise;**
- (b) whether the Government has achieved its target in Rajasthan under SCM;**
- (c) if so, the details thereof and if not, the reasons therefor;**
- (d) whether the Government has reviewed the quality of work done in various cities of Rajasthan under SCM; and**
- (e) if so, the details thereof and if not, the reasons therefor?**

**ANSWER**

**(a) to (c): 'Land' and 'Colonization' are State subjects, and hence, all the the schemes related to Urban Development, including Urban Planning are implemented by States/ Union Territories (UTs). However, Ministry of Housing and Urban Affairs (MoHUA) supplements the efforts of States and Urban Local Bodies (ULBs) in various sectors through schematic interventions and direction led programs.**

**As per the data provided by four (4) smart cities of Rajasthan, a total of 558 projects amounting to ₹8,269 crore has been completed and another 21 projects amounting to ₹371 crore are at implementation stage. As of 12<sup>th</sup> July, 2024, an amount of ₹1,078 crore has been released as Central assistance in last 5 years. All 4 cities in the State of Rajasthan have received the full fund support from Central Government under Smart Cities Mission (SCM). City-wise funds allocated in last 5 years and utilization of central funds is given at Annexure-I. Breakup of the city-wise, item-wise funds released by Centre is given at Annexure-II.**

**(d) & (e): SCM review and monitoring is a continual process and follows a three-level established monitoring mechanism i.e. at the City, State & National level. The implementation of SCM at the City level is monitored by Special Purpose Vehicles (SPVs) created for the purpose. At the State level, Mission implementation is coordinated by the State level High Powered Steering Committee (HPSC) chaired by Chief Secretary. At the National level, implementation of SCM is monitored by an Apex Committee headed by the Secretary, Ministry of Housing and Urban Affairs (MoHUA). Nominee Directors of MoHUA on the Boards of SPVs monitor progress in respective cities on a regular basis. MoHUA regularly interacts with the States/ UTs/ Smart Cities through video conferences, review meetings, field visits, regional workshops, CEO's Conference etc. at various levels to assess the performance of cities and handhold them for improving the same.**
