## †2968 SHRI MURARI LAL MEENA:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

(a) the total number of beneficiaries registered under the Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN) in Rajasthan;

(b) the measures taken/being taken by the Government to overcome the challenges in extending the welfare schemes to the vulnerable tribal groups; and

(c) the manner in which the Government proposes to cover those vulnerable tribal groups who do not have Aadhaar or MGNREGA job card under the said scheme?

## ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI DURGADAS UIKEY)

(a) to (c): Pradhan Mantri Janjati Adivasi Nyaya Maha AbhiyaN (PM JANMAN) was launched by Hon'ble PM on 15th November 2023. The mission aims has following features.

(i). It aims to provide eligible PVTG households and habitations with basic facilities such as safe housing, clean drinking water and electrification of unelectrified households with improved access to education, health and nutrition, road and telecom connectivity; and sustainable livelihood opportunities. The missions focuses on 11 critical interventions which are implemented by 9 Ministries.

(ii). The mission is for a period of 3 years with total budget of Rs.24,104 cr (including central and State share).

(iii). It covers 75 PVTG communities residing in 18 States and 1 UT. The Ministry of Tribal Affairs through the State Governments/ UT Administration/departments have undertaken habitation level data collection exercise through PM Gati Shakti mobile application to estimate PVTG population figures and infrastructure gaps in order to cover PVTG beneficiaries / PVTG villages & habitations under PM JANMAN.

The exact number of State-wise number of PVTG beneficiaries to be covered is subjected to eligibility criteria of specific guidelines of concerned interventions as per norms approved under the Mission. Based on the data captured (as on 20.07.2024), the number of PVTGs in the State of Rajasthan is 1,28,456.

(v) In coordination with State Governments, IEC (Information, Education and Communication) camps have been organized which were aimed at facilitating in provision of basic documents like Aadhar Card, Caste certificate, Jan Dhan bank account which are required for availing benefits under different schemes including PMKISAN, Ayushman Card, MNREGA etc. In furtherance, Common Services Centers (CSC) has been on boarded to facilitate preparation of these basic documents.
