#### be pleased to state:

- (a) the details of the amount collected and spent under the Central Road Infrastructure Fund (CRIF) during each of the last five years and the current year, State/UT-wise especially Maharashtra;
- (b) the details of ongoing road projects under CRIF in Maharashtra;
- (c) whether new roads have been identified for development under CRIF scheme in the State of Maharashtra and Jharkhand, if so, the details and the present status thereof;
- (d) whether funds have been allocated for the development of new roads under the CRIF scheme in Jharkhand and Maharashtra;
- (e) whether details are available on the roads selected and construction work started during the last five years in Maharashtra and Jharkhand and if so, the time by which these works are likely to be completed;
- (f) whether the Government is aware of the reports that CRIF has neither been utilized properly nor the works undertaken thereunder have been satisfactory; and

(g) if so, the steps taken by the Government to utilize the funds from CRIF as per prescribed norms and get the works executed effectively in a proper manner?

#### **ANSWER**

#### THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

### (SHRI NITIN JAIRAM GADKARI)

(a) The Ministry allocates funds for State Governments / Union Territories (UTs) for development and maintenance of State Roads under the Central Road & Infrastructure Fund (CRIF) Scheme as per the provisions of the amended CRIF Act, 2000.

State / UT – wise details of accrual and release of funds / expenditure incurred for development and maintenance of State roads under CRIF Scheme during each of the last five years and the current year, including for the State of Maharashtra, are at Annexure.

- (b) At present, 304 State Road projects in a length of about 1,604 km amounting to Rs. 6,306 Crore are under implementation under CRIF Scheme in the State of Maharashtra.
- (c) Details of the State Road projects sanctioned / finalized under CRIF Scheme in the States of Jharkhand and Maharashtra during the last five years and current year are as under:-
