FPIS IN RURAL AREAS

†543. SMT. DELKAR KALABEN MOHANBHAI:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

(a) whether the Government is giving priority to create employment in the various rural areas of the country including Dadra and Nagar Haveli and Daman and Diu;

(b) if so, the steps taken or proposed to be taken by the Government to boost the Food Processing Industries (FPIs) in the rural areas of the country so that the rural population of the country can get employment;

(c) the details of the funds earmarked/proposed to be spent in this regard; and

(d) the number of rural families estimated to be benefitted by boosting the FPIs in the rural areas of the country, State/UT-wise including Dadra and Nagar Haveli and Daman and Diu?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

(a) Ministry of Food Processing Industries (MoFPI) is supporting creation of employment opportunities through development of value chain infrastructure across country, including rural areas as well as Dadra and Nagar Haveli and Daman and Diu.

(b) & (c) MoFPI is implementing three schemes, namely Pradhan Mantri Kisan Sampada Yojna (PMKSY), Pradhan Mantri Formalization of Micro-food processing Enterprises (PMFME) and Production Linked Incentive Scheme for Food Processing Industries (PLIS-FPI) for the development of the sector. These schemes are not any region or State/UT specific but demand driven and implemented across the country.

PMKSY has a total allocation of Rs. 11,520 crore for the 14th & 15th Finance Commission cycles. Under sub-schemes of PMKSY, MoFPI mostly provides credit linked financial assistance (capital subsidy) to entrepreneurs for setting up of food processing facilities.

PMFME is operational for a period 2020-21 to 2024-25 with an outlay of Rs. 10,000 crore. Under PMFME scheme, MoFPI provides financial, technical and business support for setting up/ upgradation of two lakh micro food processing enterprises.

PLIS-FPI is being implemented over a six-year period from 2021-22 to 2026-27 with an outlay of Rs.10,900 crores and it is intended to support creation of global food manufacturing champions and support Indian brands of food products in international market.

(d) The State/UT-wise details of expected employment opportunity creation under the said three schemes, including Dadra and Nagar Haveli and Daman and Diu, is given at **Annexure**.
