MALNUTRITION AMONG CHILDREN IN ANDHRA PRADESH

873. SHRI KESINENI SIVANATH

Will the Minister of Women and Child Development be pleased to state:

- (a) The details of malnourished children in the country during the last five years, State-wise, specially in the State of Andhra Pradesh, district-wise;
- (b) The details of the schemes that have been implemented by the Government to treat malnourishment in the State of Andhra Pradesh, and
- (c) The details of the fund provided to these schemes, year-wise along with funds that has been utilized?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI ANNPURNA DEVI)

(a) The National Family Health Survey (NFHS) conducted by Ministry of Health & Family Welfare captures the nutritional indicators of children. As per the latest NFHS-5 (2019-21) report, the National nutrition indicators for children under 5 years are as follows: Stunting is 35.5%, Wasting is 19.3% and Underweight is 32.1%. The nutritional indicators of children under 5 years of State of Andhra Pradesh as per NFHS-5 report are: Stunting is 31.2 %, Wasting is 16.1% and Underweight is 29.6%.

As per the data of Poshan Tracker for the month of June 2024, around 8.57 crore children under 6 years were measured, out of whom 35% were found to be stunted, only 17% were found to be underweight and only 6% children under 5 years were found to be wasted. The levels of underweight and wasting in children as obtained from Poshan Tracker are much less than those projected by NFHS 5.

As per June 2024 data of Poshan Tracker for the State of Andhra Pradesh, 20% children are stunted, 5% children are wasted and 10% children are underweight. The State-wise data of nutrition status of children including the State of Andhra Pradesh of June 2022, June 2023 and June 2024 data of Poshan Tracker is provided in Annexure I. District-wise nutrition status of children of State of Andhra Pradesh as per June 2024 data of Poshan tracker is placed at **Annexure II.**

(b) Under 15th Finance Commission, Anganwadi services, Poshan Abhiyaan and Scheme for Adolescent girls (14-18 years in Aspirational Districts and North-East

region) were subsumed under Mission Saksham Anganwadi and Poshan 2.0 (Mission Poshan 2.0). Mission Poshan 2.0 seeks to address the challenge of malnutrition through improved nutrition content and delivery. This is a universal self-selecting (no entry barriers) scheme available to all the beneficiaries who enrol at the AWCs and is being implemented in all States/UTs across the country including the State of Andhra Pradesh.

Under Mission Poshan 2.0 a strategic shift has been made for reduction in malnutrition and for improved health, wellness and immunity through community engagement, outreach, behavioral change, and advocacy. Mission Poshan 2.0 focuses on Maternal Nutrition, Infant and Young Child Feeding Norms, treatment of Severe Acute Malnutrition (SAM)/ Moderate Acute Malnutrition (MAM) and wellness through AYUSH practices to reduce wasting and underweight prevalence beside stunting and anaemia. Supplementary Nutrition is provided in accordance with the nutrition norms contained in Schedule-II of the National Food Security Act. To address the challenge of malnutrition more effectively, these nutrition norms have been revised. The old norms were largely calorie-specific; however, the revised norms are more comprehensive and balanced in terms of both quantity and quality of supplementary nutrition based on the principles of diet diversity that provides quality protein, healthy fats and micronutrients. Only fortified rice is being supplied to AWCs to meet the requirement of micro-nutrients and control anaemia among women and children. Greater emphasis is being given on the use of millets for preparation of Hot Cooked Meal at least once a week and Take Home ration (THR – not raw ration) at Anganwadi centers for beneficiaries.

Ministry of Women & Child Development and Ministry of Health & Family Welfare jointly released the protocol for Community Management of Malnutrition (CMAM) to prevent and treat severe acute malnutrition in children and for reducing associated morbidity and mortality.

Under Mission Poshan 2.0, one of the major activities undertaken is Community Mobilization and Awareness Advocacy leading to Jan Andolan to educate the people on nutritional aspects. State and UTs are conducting and reporting regular sensitisation activities under community engagement programmes during Poshan Maahs and Poshan Pakhwadas celebrated in the months of September and March-April respectively. Community Based Events (CBEs) have served as a significant strategy in changing nutrition practices and all Anganwadi workers are required to conduct two Community Based Events every month.
